

### Instructions for Valuable Member Benefit —

wa3listserv@listserve.com

### What is a Listserve?

A Listserve is an email based connection tool. When you subscribe to a listserve you will periodically receive emails from others that also subscribe to the listserve asking questions or relaying information. Asking questions will probably be the way the Apartment Association will use it however the association office can use it to let you know what is going on.

For example: If Mr. Bob from Bob's Properties (obviously made up names) is looking for a reputable slate roof person he could click on <a href="mailto:wa3listserv@listserve.com">wa3listserv@listserve.com</a> and type the question......"I am looking for a good slate person. Does anyone have any suggestions?" All person subscribing to the listserve would see the email and all persons subscribing to the listserve would be able to respond. All responses will also be seen by all subscribers.

### Listserve Etiquette.

As with any community, there are guidelines governing behavior on the WA3 List Serves. For instance, violating antitrust regulations, libeling others, selling, and marketing are not permissible. Please take a moment to acquaint yourself with these important guidelines. Wa3 reserves the right to suspend or terminate membership on all lists for members who violate these rules.

- Do not challenge or attack others. The discussions on the lists are meant to stimulate conversation not to create contention. Let others have their say, just as you may.
- Do not post commercial messages. The cyberspace term for this is spamming. Contact people directly with products and services that you believe would help them.
- Use caution when discussing products. Information posted on the lists is available for all to see, and comments are subject to libel, slander, and antitrust laws.
- All defamatory, abusive, profane, threatening, offensive, or illegal materials are strictly prohibited. Do not post anything in a list serve message that you would not want the world to see or that you would not want anyone to know came from you.
- Remember that WA3 and other e-mail list participants have the right to reproduce postings to this list serve.
- Include a signature tag on all messages. Include your name, affiliation, location, and e-mail address.
- State concisely and clearly the specific topic of the comments in the subject line. This allows members to respond more appropriately to your posting and makes it easier for members to search the archives by subject.
- Include only the relevant portions of the original message in your reply, delete any header information, and put your response before the original posting.
- Only send a message to the entire list when it contains information that everyone can benefit from.
- Send messages such as "thanks for the information" or "me, too" to individuals--not to the entire list.
- Do this by using your e-mail application's forwarding option and typing in or cutting and pasting in the e-mail address of the individual to whom you want to respond.
- Do not send administrative messages, such as remove me from the list, through the list serve.

Do not respond if you have no answer.

# **PMAM Legislative Committee Report**

# BILLS THAT PMAM IS WORKING ON IN ORDER OF BOARD PRIORITY

**BEDBUGS.** Rep. Iden (R-Kalamazoo Co.), who sponsored our bill last year, introduced the bill. It is HB 4719 and it has been referred to the House Committee on Law and Justice.

EMOTIONAL SUPPORT ANIMALS. We have drafted a proposed bill to amend MCL 752.61 which makes it a misdemeanor to falsely claim that an animal is a service animal. Our bill would extend that criminal liability to people who falsely claim an animal is an emotional support animal and it would impose criminal liability to health care providers who falsely state that a person needs an emotional support animal. The Act we are seeking to amend passed unanimously in 2015 and we are hopeful that our common-sense amendments will do the same. We are discussing co-sponsorship between a Republican and Democratic Senator for introduction in the Senate

LATE FEES. This bill, which was introduced last session, would allow for late fees incurred as a result of late payment of rent to be counted as "rent" for the purposes of landlord-tenant proceedings, as well as creating a baseline under which a late fee is construed not to be a penalty and enforceable. The amount would be the greater of \$50 or 10% of the rental rate. We are working with a new potential sponsor of our bill in the House as our sponsor from last session could not run for re-election because of term limits.

LICENSING. We have drafted a proposed bill which would eliminate the requirement for a leasing agent or community manager to be a licensed real estate salesperson and which would remove the 25-mile requirement for a real estate broker's branch office being used for residential property management to have a separate license and an associate broker. We will look for a sponsor for this bill. The problem is that the Realtors oppose any change to this licensing requirement. Rep. Green (D-Macomb Co.) has drafted a bill (which has not been introduced) to create a separate rental property license to take the place of the real estate salesperson's license. The Committee opposes Rep. Green's bill because we do not support additional licensing.

SB 62 - Sen. Hertel (D-Ingham Co.)/Lead Paint. Amends public health code by cutting in half the lead paint exposure standard. STA-TUS: Unchanged. In Senate Health Policy Committee. OPPOSE SB 110 - Sen. Schmidt (R-Grand Traverse Co.)/Amends Anti-Rent Control Statute/Clarifies that Affordable Housing Incentives Do Not Violate. Amends Rent Control Statute to specifically authorize affordable housing incentives. Appears that perhaps some opponents of affordable housing have argued that incentives violate Michigan's Rent Control Prohibition. Any change to this statute should be monitored closely for unintended consequences. STATUS: Unchanged. In Senate Local Gov't Comm. OPPOSE any amendment to the Rent Control ban statute because of possible unintended consequences. HB 4456 - Rep. Chang (D-Detroit)/Repeals Anti-Rent Control Statute. Democrat sponsored bill to completely repeal state's rent control ban. STATUS: New bill. In House Local Gov't Comm. OPPOSE. PMAM is hoping that the locals' respective legislative committees will meet in district with the Democratic co-sponsors of this bill during summer recess to explain our opposition.

SB 126 – Sen. Kowall (R-Oakland Co.)/Real Estate/Continuing Ed. Amends real estate licensure continuing education requirements. STATUS: Became law as PA 56 of 2017.

SB 107 – Sen. Jones (R-Eaton Co.)/Rental Inspections. Amends multi-unit housing act provisions regarding maximum time between inspections (changes max time between inspections if no violations depending on inspection methodology) and replaces current access provisions with a good faith effort provisions. STATUS: Passed the Senate and is awaiting referral and action in the House. SUPPORT HB 4086 – Rep. Tedder (R-Oakland Co.)/ SB 255 – Sen. Green (R-Tuscola Co.)/Home Inspection Licensure. Amends occupational code to license home inspectors. Potentially has some application to multi-family housing. STATUS: Unchanged. In both Regulatory Reform Committees. NEUTRAL

HB 4434 – Rep. Neely (D-Flint) / Housing; housing development authority; requirement to offer vacant apartments to mobility-impaired tenants. STATUS: In House Local Gov't Comm. NEUTRAL HB 4463 – Rep. Van Singel (R-Oceana Co.)/Landlord-Tenant/ Eviction/Allows LLC members to represent themselves in certain cases. This bill would allow single-member LLC's (or husband and wife two-member LLC's) suing for less than the small claims maximum to represent themselves without lawyers in landlord-tenant cases. STATUS: In House Law & Justice Committee. SUPPORT SB 329 - Hune (Livingston)/Short Term Rentals/Ban Certain Zon-

SB 329 - Hune (Livingston)/Short Term Rentals/Ban Certain Zoning Restrictions & HB 4503 - Rep. Sheppard (R-Monroe). Amends Zoning Enabling Act to classify short-term rental (less than 28 days applies to house, 1 to 4 unit apartment or condo unit[s]) as a residential use allowable in a residential zone; exempts from special or conditional use permits; exempts from definition of a commercial use. Billing being pushed by Realtors. This would aid AirBnB and VRBO rentals. STATUS: In Sen Local Gov't & House Tourism.

HB 4100 – Rep. McCready (R-Oakland Co.)/ Regulate Stormwater Management Utilities by Local Municipalities. Bill would allow for uniform stormwater collection fees. STATUS: In House Local Government.

**HB 4847 – Rep. Lucido (R-Macomb Co.)**/ Rent Adjustments. Bill would codify the case law which allows a landlord of a month-to-month tenant to raise the rent upon 30 days' notice.

STATUS: In House Local Government.

**HB 4872 – Rep. Byrd (D-Detroit)/** Housing Discrimination. Bill would add "military status" as a protected class which could not be discriminated against in housing and other areas.STATUS: In House Military and Veterans Affairs. **SUPPORT**

# **2017 Real Estate Continuing Ed**

Scott Allan Larry unexpectedly passed away in Phoenix, Arizona on Sunday, Septem-

ber 10, 2017 at the age of 59. Scott will be forever remembered by the love of his life, best friend and wife, Elaine, along with his sons Nick (Clair) and Alec, and his stepson Kevin, his sister Lynn (Neal) and niece Natalie.

Scott had a long career in construction that started with the Taubman Company in 1977. He later joined Lockwood Companies where he worked and consulted for much of his career. Scott formed his own company, DePadua Construction (named after the hospital in Chicago where he was born), and continued to excel in the major rehabilitation of apartments. DePadua thrived since its inception in 1995 completing over 65 projects and more than 7,200 units.

Scott would serve as President and later Chairman of the Michigan Housing Council, where he worked closely with MSHDA, HUD and other industry participants to resolve issues and make Michigan a better place to do business. Many residents of Michigan have affordable homes because of Scott's efforts.

Outside of his career, Scott had a great many interests. He was a Rugby player in his younger days and a "gearhead" his entire life. He was a devoted Cheesehead and shareholder of the Green Bay Packers as well as a diehard Chicago Cubs fan. An avid cycling fan and a great fan of Formula One racing, Scott attended countless races in the US and around the world. In 2015, Scott was able to fulfill a lifelong dream of owning a race car. He joined INDE Motor Sports Ranch and became part of a family of people passionate about motor sports. In recent years, Scott was living his dream - racing cars in Arizona and spending time with the woman of his dreams.

Scott touched so many through his career and his passions. He will be missed by all.




